

TOO CHEAP TO BUY YOUR OWN TICKET

VANCOUVER FILM & TELEVISION FORUM CONTEST REGULATIONS

1. ENTRY PROCEDURE

To enter the 2008 " Too Cheap to Buy Your Own Ticket Contest" (the "Contest") contestants must be registered on **Facebook** and complete their answers on the Vancouver Film and Television Forum's Group page. Contestants may enter as many times as they like.

The Contest will be open from 10:00AM August 15, 2008 until 11:59PM (EDT) on September 12, 2008. All entries become the exclusive property of THE FORUM. No purchase is required.

2. CONDITIONS OF ELIGIBILITY

Contestants must be Canadian Citizens or landed immigrants and residents of British Columbia, Canada. Contestants must have reached the age of majority at the time of participation in the Contest. Directors, officers and employees of the THE FORUM, the Vancouver Film Festival and their affiliates, licensees, and their immediate family (father/mother, brother/sister, son/daughter) or persons living under the same roof with them are not eligible to enter this Contest.

Contestants must abide by all rules, regulations and etiquette associated with Facebook.

3. PROCEDURE FOR AWARDING PRIZE

On September 15, 2008 The Forum will select four (4) winners from all eligible entries received, on THE FORUM's Facebook Group Page.

The winning entries will be deemed to be made by the authorized account holder who has signed up for and been accepted as a Facebook account holder.

Attempts will be made to contact the selected contestants through Facebook and contestants must respond within two (2) days of the first attempt. If a contestant cannot be contacted or does not respond within the above time period, an alternate name will be selected from the original list of eligible entries. To be declared a winner, the selected person must sign and return the acceptance letter provided by THE FORUM within five (5) days of receipt and otherwise meet and comply with all conditions of these regulations. The winners must pick up their prize in person at the Box Office at the Vancouver Film Centre, 1181 Seymour Street, Vancouver BC between September 24 – September 26.

4. DESCRIPTION OF PRIZE

The Prize is as follows:

A full Day Pass to New Filmmakers' Day (NFD) on September 27, 2008 that entitles the winner to attendance at all sessions during NFD plus the reception following. New Filmmakers' Day takes place during the Film and Television Forum at the Vancouver International Film Centre, 1181 Seymour Street, Vancouver BC.

All other expenses, and more specifically but not restricted to, all means of transportation, all meals and refreshments, personal and incidental expenses are the responsibility of the winner.

If the winner is unable to attend New Filmmakers' Day on September 27, 2008, the prize will be forfeited and an alternate winner selected and no compensation or alternative prize will be offered or provided.

Four (4) New Filmmakers' Day passes are available to be won. Only one (1) New Filmmakers' Day Pass can be won per person.

Total approximate value of each prize is \$70.

5. GENERAL RULES

5.1 The winner shall agree, if necessary, to have his/her contest response, name and/or image used for advertising purposes connected with The Forum, in any media, without notice or compensation in perpetuity.

5.2 The prize shall be accepted as is and may not be exchanged for an amount of money, nor sold nor transferred. No substitutions will be allowed.

5.3 Refusal to accept the prize releases the THE FORUM of all responsibility and obligations.

5.4 THE FORUM shall assume no liability resulting from losses, delays, typographical errors, poor technical or telephone operations, losses of mail or e-mail, loss or stealing of data-processing, breach of software or computer equipment, or fraudulent calls, for any failure of any websites during the promotional period, for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, access providers, computer equipment, software, or failure of any e-mail or entry to be received by THE FORUM on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof including any injury or damage to an entrant's or any other person's computer related to or resulting from participation in the Contest or viewing or downloading any Contest material. THE FORUM reserves the right, in their sole discretion to cancel or suspend the Contest without prior notice should a virus, bug or other cause beyond the reasonable control of the Contest Partners corrupt the security or proper administration of the Contest. Any attempt to deliberately damage any web site or to undermine the legitimate operation of this promotion is a violation of criminal and civil laws, and should such an attempt be made, THE FORUM reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution. Entries are subject to verification and will be declared invalid if they are incomplete, illegible, garbled, mechanically reproduced, mutilated, forged, falsified, altered or tampered with in any way.

5.5 THE FORUM shall assume no liability of any kind whatsoever in any cases in which its inability to act results from an event or situation unforeseeable or beyond their control, including more particularly a strike, lock-out or any other labour dispute in their place of business or the places of business of the organizations or businesses whose services are used to hold the Contest.

5.6 All names and any other personal information gathered on the Facebook Contest website are gathered for the purpose of administering the Contest and will not be shared with any third parties who are not directly associated with the Contest.

5.7 Should a contestant make any false statement as determined, in the sole and conclusive opinion of THE FORUM, he/she shall be automatically disqualified from the Contest.

5.8 Participation in the Contest includes acceptance of these regulations, which shall be applied by the THE FORUM. All its decisions are final.

5.9 This Contest is organized and administered solely by THE FORUM presented by the Vancouver International Film Festival.
